AMENDED ARTICLES OF INCORPORATION

OF

JJARBOR STAR SHIPPING SERVICES, INC.

(Formerly: SEATOWS, INCORPORATED)

KNOW ALL MEN BY THESE PRESEN'S:

That WE, the undersigned, all Filipino citizens, of legal age, and residents of the republic of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a stock corporation, under the laws of the Republic of the Philippines;

AND WE HEREBY CERTIFY.

FIRST :- That the name of the corporation shall be "SHIPPING SERVICES, INC.

and shall operate and transact business under the said firm name.

as amended on Nov-27,1998.

SECOND: - That the purposes for which such corporation is formed are.

PRIMARY PURPOSE

1) To engage in towage, commerce and navigation in the carriage of goods and passengers by water upon the seas, sounds, lakes, rivers, canals, bays, harbors, and other waterways between the various ports of the Philippines as amended June 24,1998.

SECONDARY PURPOSE

To engage in ocean towage, commerce and navigation in the carriage of goods and passengers by water upon the oceans, seas, sounds, lakes, rivers, canals, bays, harbors, and other waterways between the various ports of the Philippines and between such ports and other ports of the world

11)In general to do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the furtherance of any of the powers herein above set forth either alone or in association with other corporation, firms or individuals, and to do any act or acts, thing or things, incidental or appertaining to or growing out of, or connected with the aforesaid business or cowers, or any part thereof, provided the same is not inconsistent with the laws of the Philippines as amended June 24,1998

THIRD : - The place where the principal office of the corporation is to be established or located shall be in Manila

FOURTH : - That the term for which said corporation is to exist is fifty years from and after the date of issuance of the certificate of incorporation as amended June 24,199_o.

FIFTH : - That the names, nationalities and residences of the incorporators of the corporation are as follows:

- 2) To engage in the salvage business in the Philippines and elsewhere, to buy sell, trade, deal in and manufacture of salvage equipment including but not limited to barges, vessels and other kinds of floating equipments.
- 3) To contract for, operate, build,own,equip,furnish and fit sell,mortagage,or rate and charter to or from other persons, forms or corporations and to navigate, operate steam, sail or other boats, ships, vessels, tugs, barges and lighters or other properties used in any lawful business, trade, commerce navigation or the transportation of freight.
- To build, own, manage and/or operate shipyards.
- 5) To engage in the business of importing, exporting, trading, buying and selling goods merchandise, wares of any kind and description; and generally, to carry on any mercantile activity which is directly or indirectly calculated to promote the business of the corporation;
- 6) To own, operate and manage a container yard and render trucking and freight services;
- 7) To purchase, hold, sett, and re-issue the shares of its own capital stock, without however being a stockholders or dealer in stock;
- 8) To enter, make, perform, and carry our contracts of every kind for any lawful purpose, without limit as to amount with any person, firm association or corporation;
- 9) To borrow or raise money without limit and upon any terms for any purpose of this corporation or of any corporation, association, firm, syndicate, or individual having a business or property which this corporation determines to finance, promote or become interested in;
- 10)To invest and own stock in other corporations within the limits of the corporation law and to promote new enterprises;
